Institute for Security & Development Policy

Report for the fiscal period January-December 2008

The Institute for Security and Development Policy is a Stockholm based independent and non-profit research and policy institute. The Institute is dedicated to expanding understanding of international affairs, particularly the interrelationship between conflict, security, and development. The Institute's primary areas of geographic focus are Asia and Europe's neighborhood. Research ranges from short research projects involving a sole researcher to larger, multi-year cooperative endeavors involving numerous researchers and institutions. This research is undertaken mainly at the Institute's offices. The Institute incorporates the Asia Program and the Silk Road Studies Program. The latter constitutes, since 2005, a Joint Center with the Central Asia-Caucasus Institute, Johns Hopkins University-SAIS.

ISDP often receives guest researchers at its office in Stockholm. With funding either from the Institute itself or from collaborating institutions or sponsors, such visitors carry out research which leads to monographs, articles, policy papers, or presentations in various media. Scholars stay for periods ranging from a few weeks to a year or more. Since the founding of ISDP, the Institute has hosted close to 60 Fellows and guest scholars. These have come from across Europe, Asia, and North America, as well as from many of the countries that the Institute focuses on. Among their number have been former and future ministers, heads of institutes of strategic studies, academics, NGO representatives, ambassadors, military experts, and senior parliamentary staffers. In fields formerly dominated by men, women have been prominent among scholars at the Institute.

The Institute's research is conducted along thematic as well as regional lines. The thematic areas are: Conflict Management and Mediation, Security and Political Violence, State Building, Governance and Human Rights, Narcotics and Organized Crime, Energy, and European and American Policies. The geographical focus stretches from the Wider Black Sea Region and the Baltic Sea Area to the Korean Peninsula and Japan. Northeast, Southeast, and South Asia are covered within the Asia Program; the area spanning from Turkey to Western China, including the Caucasus, Black Sea-Caspian Sea basin, and Central Asia, is covered by the Silk Road Studies Program. The Baltic Sea region and the European Neighborhood, including Russia, are increasingly important areas of the Institute's work.

CONFERENCES

The ISDP organizes occasional conferences and workshops.

January 16-17

Conference "The political Roles of Religious Communities in Northern India" in cooperation with Maulana Abul Kalam Azad Institute of Asian Studies (MAKAIAS). The conference was organized in cooperation with the Maulana Abul Kalam Azad Institute of Asian Studies in Kolkata, India. The focus was multidisciplinary, including perspectives from sociology, economy, political science, law and the history of religions. The aim was to discuss key questions within the discourse of religion and how it shapes the context of identity. The Kolkata conference is the second conference held within the South Asia project, the first was held in Islamabad, Pakistan on October 29-30, 2007.

January 28-29

The workshop on "Security and Development in Southeast Asia: Views Up Close and from Afar" organized by the ISDP in Stockholm, addressed the issue of



Myanmar/Burma in the aftermath of the military government's crackdown on demonstrations in September 2007 and its wider implications for the region and beyond. The workshop convened a diverse pool of country and regional expertise from China, ASEAN, and the EU. An opportunity was afforded to participants to present, consider, and debate the complex problems of Myanmar/Burma in a frank and realistic manner.

February 14-15

Conference on "Perspectives on Africa Today - A Swedish-Chinese -African Dialogue" organized in cooperation with the Dag Hammarskjöld Foundation in Uppsala in Stockholm and Uppsala. The participants were selected Chinese,



African and Swedish researchers and policy-makers. It intended to seek a mutual understanding with the aim to identify the scope for cooperation in the best interest of all parties and facilitated an informal exchange between African, Chinese and Swedish participants. The intention was to build dialogue to foster confidence and trust by identifying common interests and concerns within the current constellation between African, Chinese and Swedish stakeholders. Invited participants have been intensively involved with or have a sincere interest for

the Sino-African partnership.

June 2-3

Conference on "Security and Development in Asia: New Threats and Challenges in the Post-Postwar era". The conference held numerous speakers ranging from Swedish National Defense College, Swedish Ministry for Foreign Affairs, United States War College, the ISDP and as well various universities from around the world. The conference aimed at addressing topics regarding conflict and post-conflict situations in Asia, with two main focuses; how security challenges of the 21st century can be dealt with and to elucidate what can be done to bridge fears and suspicion lingering in the region and the as well timeliness and adequacy of resources and how they can be made available in post-conflict situations. The conference was funded by the Japan Foundation.

September 4-5

Seminar on "Drug Trafficking and Organized Crime in the Baltic Sea Region" in Riga, Latvia. Together with the European Cities Against Drugs (ECAD), ISDP arranged a series of two working group seminars held in



Riga and a concluding conference to be held in St. Petersburg, all funded by ECAD. During these events, invited law enforcement officers and researchers have been given the opportunity to meet and discuss the current situation with regard to narcotics and organized crime and to compare trends in their respective countries. The seminars have been much appreciated by the participants and are proposed to be continued in the future. A working report to sum up the discussions and put forward some policy recommendations will be published towards the end of the year by ISDP.

September 10-11

Transatlantic Energy Dialogue. In cooperation with the Swedish Ministry for Foreign Affairs and the U.S. NIC, ISDP arranged a two-day seminar on Transatlantic Views on Energy Security, featuring high-level officials from the United States and EU states as well as the European Union and independent experts. A conference report appears in October.

September 19-21

International Symposium on "Military Reform: Practices and lessons". The aim of the conference was to exchange experiences and views on factors that have influenced, and influence, radical military reform processes. Particular attention was addressed to get a broad representation, from several countries, as to see if there were any general conclusions that could be drawn, applicable to such processes. The conference was the first in a series of annually recurrent conferences on different policy related questions. The conference was a joint project with the PLA Academy for Military Science (AMS).

November 6-7

International seminar on "Narcotics and organized crime in the Baltic Sea Region in St. Petersburg" which was co-organized with European Cities Against Drugs (ECAD). This was the concluding seminar of a total three, the first two which were held in Riga. Researchers and law enforcement officers from Russia, Estonia, Latvia, Lithuania, Poland and Sweden attended the seminar. The topic for the event was the latest trends in narcotics and organized crime.

November 18-19

Regional Development and New Challenges to International Relations (ISDP Advanced Seminar Kunming). To understand various aspects of change in Myanmar since the country adopted its new Constitution, ISDP held an advanced seminar in Kunming to gather scholars from research institutes and think tanks in China, Myanmar, Europe, and U.S. The discussion was focused on political development in Myanmar, the role of regional actors, what can be anticipated from the upcoming general elections, and what the result will mean to the international community. Participants from ISDP included Niklas Swanström (Director), Robert Nilsson (Deputy Director) and Xiaolin Guo (Senior Research Fellow).

November 27-28

ISDP arranged a seminar on "Organized Crime in the Baltic Sea Region and Black Sea Region" in Kiev, Ukraine, in cooperation with the Ukraine Ministry of Interior. Participants from Estonia, Latvia, Lithuania, Poland, Moldova, Georgia, Belarus, Ukraine and Swe-

den were invited. The participants were researchers with focus on organized crime as well as representatives from law enforcement agencies. The aim for the seminar was to develop understanding of criminal trends and activities in the entire region. Discussed during the workshops were possibilities to enhance collaboration in crime prevention in general and fighting organized trade in narcotics in particular. ISDP intention is that this will project will lead to a closer partnership between countries in the Baltic Sea region and countries in the Black Sea region.

GUEST RESEARCHERS AND FELLOWS

The ISDP regularly welcomes distinguished academics and prominent practitioners in order to enrich its research environment. Visitors carry out research that often leads to monographs, policy papers and open seminars.

The guest researchers and fellows at ISDP often deliver seminars and lectures at prominent institutions in Sweden and in other Scandinavian countries such as the Swedish Defence Research Agency, SIPRI, the Stockholm School of Economics, Stockholm University, SIIA, NIAS, Oslo University, the Folke Bernadotte Academy, the Swedish National Defence College. The sharing of knowledge contributes to the development of our fields of research and opens new communication channels for professionals.

September 2007—May 2008

Prof. Chen Yue Xue from Beijing University of Agriculture started her one year stay at the Institute in September 2007. Her research deals with rural economic development of China and China-Taiwan trade relations. Prof. Chen received a scholarship from the Swedish Institute.

foreign affairs, the preconditions for a diversified energy supply, and key projects for direct European access to the energy resources of the Caspian region. Featuring contributions by leading experts in the energy security field, this volume is aimed to inform the contemporary debate on European energy security, and provide European decision makers with concrete policy advice.

Xiaolin Guo, ed., Myanmar/Burma: Challenges and Perspectives, April 2008.

This collection of papers addresses political developments in Myanmar/ Burma in the context of regional politics and changing international relations. It seeks to disentangle and elucidate pressing issues that affect not only democratization in the country but also nation building. Part One of the book deals with problems of the prodemocracy movement, ethnic conflict, and the role of the military in any future political transition and its implications for the country and the region. This book aims to invigorate the debate and diversify the discourse on Myanmar/Burma.



Xiaolin Guo, *State and Ethnicity in China's Southwest*, June 2008, Brill Publications.





Marlène Laruelle, Russian Eurasianism: An Ideology of Empire, Woodrow Wilson Center Press, October 2008.



In recent years, however, leading Russian figures, including former president Vladimir Putin, have begun to stress a geopolitics that puts Russia at the center of a number of



axes: European-Asian, Christian-Muslim-Buddhist, Mediterranean-Indian, Slavic-Turkic, and so on. This volume examines the political presuppositions and expanding intellectual impact of Eurasianism, a movement promoting an ideology of Russian-Asian greatness, which has begun to take hold throughout Russia, Kazakhstan, and Turkey. Eurasianism purports to tell Russians what is unalterably important about them and why it can only be expressed in an empire. Using a wide range of sources, Marlène Laruelle discusses the impact of the ideology of Eurasianism on geopolitics, interior policy, foreign policy, and culturalist philosophy.

Christopher Len, Uyama Tomohiko, Hirose Tetsuya, eds, Japan's Silk Road Diplomacy: Paving the Road Ahead, CACI-SRSP, December 2008

In 2007 Japan celebrated its tenth anniversary of the launch of its Eurasian Diplomacy. Introduced in 1997, the idea was that Japan should play an active and leading role to help Russia, China and as well the Newly Independent States in Central Asia to foster political and economic stability.



While Japan's engagement with Russia and China have been well documented over the past decade, Japan's contribution to the Central Asia-Caucasus region is less known, and in fact, poorly understood, especially outside Japan. This publication concentrates mostly on Japan's engagement with Central Asia with the hope that it will shed light on this subject matter. Through this edited volume from a group of authors, the intention is to reach out to policy-makers and scholars everywhere with an interest in Central-Asia to help them better understand the intentions and role of Japan in Central-Asia.

Bert Edström, Japan and the Challenge of Human Security: The Forming of a New Policy 1995-2003, December 2008

The 1990s was a decade of upheaval. After the collapse of the bipolar Cold War world order epitomized by the US–Soviet confrontation the possibility of a major war was greatly reduced. The emergence of a new world order meant a challenge for Japan's foreign and security policies, since they were



premised on the Cold War cleavage of the world with two ideologically hostile blocs pitted against each other. The contours of a more assertive Japanese foreign policy could gradually be discerned. One element of the change that took place was seen in 1998 when human security was made a key concern of Japan's foreign policy. The key actor behind this policy shift was Prime Minister Obuchi Keizō. Spearheading the promotion of this security idea, he initiated an international campaign that put Japan at the forefront of championing human security. This is the first comprehensive account of the background to Japan's pursuit of human security, and traces the evolution of its policy on human security during its formative period.

Anna Jonsson, ed., Human Trafficking and Human Security, Routeledge: London, 2009

Human trafficking, and the related problems of organized crime and prostitution, has become a serious problem for post-Soviet countries since the dissolution of the Soviet Union. Human trafficking has a major impact on the countries of origin, the destination countries and the countries of transit, and is a concern for those studying popu-



lation and migration, economics, politics, international relations and security studies. This book examines human trafficking from post-Soviet countries, exploring the full extent of the problem and discussing countermeasures, both local and at the global level, and considering the problem in all its aspects. It focuses in particular on the experiences of the Baltic Sea region, setting out the nature of organized crime and the full range of threats against society.




THE CHINA AND EURASIA FORUM: WEEKLY NEWSLETTER

From 1991 to 2007, Mr. Karaveli served as editorial writer at the Swedish daily Östgöta Correspondenten. Mr. Karaveli regularly appears in Swedish media as a commentator on Turkish affairs. He has lectured on Turkish Affairs at the invitation of the Uppsala University, The Swedish Migration board, the Swedish Conservative party (Moderaterna) and the Board of Swedish Trade Union of Municipal employees. Mr. Karaveli has in particular stressed the importance of secularism as a lever for democratization, most recently in the policy journal *Europe's world*. His op-eds have also been published in the Turkish press.

Ms. Elin Kinnander started a five-month internship at the ISDP this October as an Assistant Editor of the Turkey Analyst and in addition deals with issues concerning South Caucasus and Turkey. Ms. Kinnander is currently finishing a B.A. Degree in political science and a M.A. degree in Oriental studies at Uppsala University. Klas Marklund has started working at the ISDP. Mr. Marklund specializes in terrorism and security matters in Southeast Asia.





The Institute for Security and Development Policy is a Stockholm-based independent and non-profit research and policy institute. The Institute is dedicated to expanding understanding of international affairs, particularly the interrelationship between conflict, security, and development. The Institute's primary areas of geographic focus are Asia and Europe's neighborhood. The Institute incorporates the Asia Program and the Silk Road Studies Program. The latter, formerly affiliated with Uppsala University, constitutes, since 2005, a Joint Center with the Central Asia-Caucasus Institute, Johns Hopkins University-SAIS. The Institute's core funder for 2008 was the Swedish Ministry for Foreign Affairs, however the ISDP is in the process to diversify its funding in the future.

The ISDP fosters both fundamental and applied research in a wide range of disciplines in the social sciences and humanities, with a focus on issues of conflict, security and development. This research ranges from short research projects involving a sole researcher to larger, multi-year cooperative endeavors involving numerous researchers and institutions. This research is undertaken mainly at the institute's offices.

The Institute's research is conducted along thematic as well as regional lines. The thematic areas are: Conflict Management and Mediation, Security and Political Violence, State Building, Governance and Human Rights, Narcotics and Organized Crime, Energy, European and American Policies. The geographical focus stretches from the Wider Black Sea Region and the Baltic Sea Area to Korean Peninsula and Japan. Northeast, Southeast, and South Asia are covered within the Asia Program, the area from Turkey in the West to Western China in the East, including the Caucasus and the Black Sea-Caspian Sea basin, is covered by the Silk Road Studies Program, The Baltic Sea region and the European Neighborhood, including Russia, are increasingly important areas of the Institute's work.
