#### Leadership Group for Industry Transition (LeadIT) Annual Summit - COP29, Baku

On November 20, 2024, India and Sweden cohosted the annual summit of the Leadership Group for Industry Transition (LeadIT) on the sidelines of COP29 in Baku. This summit focused on accelerating the low-carbon transition of hard-to-abate sectors, a critical step in addressing global climate challenges.

Minister of State for Environment, Forest & Climate Change of India, Shri Kirti Vardhan Singh, and Minister for Climate and the Environment of Sweden, Ms. Romina Pourmokhtari, released the five-year report of LeadIT. The report outlines progress in promoting sustainable practices and transitioning industries towards more environmentally friendly operations.

The membership of LeadIT initially consisted of nine





countries and several companies when it was initiated in 2019. This has now grown to 18 countries and 23 companies. The most recent additions are Indian automotive giant Ashok Leyland, Canadian green hydrogen pioneers World Energy GH2 and Swedish green steel scale-up Stegra.

The India-Sweden Industry Transition Partnership (ITP) was launched, as part of LeadIT, by Indian Prime Minister Narendra Modi and Swedish Prime Minister Ulf Kristersson at COP28, held in 2023 in Dubai. The ITP's mission is to accelerate the global decarbonization of heavy industry. It aims to do this by unlocking flagship projects in the steel and cement sectors and helping foster enabling conditions for decarbonization by supporting innovation and research and development, mobilizing finance and advancing market-based mechanisms.

The summit reinforced the commitment of member countries and companies to the shared goal of a low-carbon future, with an emphasis on collective action to tackle climate change.

### India-Sweden Sustainability Day 2024 Drives Green Transition

On December 13, 2024, India and Sweden strengthened their collaboration on sustainability and decarbonization at the 2nd India-Sweden Sustainability Day held in Mumbai. Organized by Team Sweden in India, the event focused on industry transition, green technologies, and knowledge sharing. It brought together key stakeholders from government, industry, and academia, fostering discussions on strategies for decarbonization. Sweden, which recorded its lowest energy-related emissions in five decades in 2023, shared its vision to achieve carbon neutrality by 2045. India, targeting net-zero emissions by 2070, seeks to benefit from Sweden's advanced technologies and strategies.

The highlight was a panel discussion, "Breaking Barriers: Innovative Approaches to Sustainability in High-Emission Sectors," featuring companies like Atlas Copco, Tata Power, and Mahindra Group. They shared solutions for reducing emissions in sectors like steel, cement, and energy. Another session, "Impact: Unlocking a Sustainable Future," showcased collaborative projects from Volvo Group, Kalyani Steel, and others.

Long-standing initiatives such as the India-Sweden Green Transition Partnership and Green Hydrogen Cluster have already driven over 20 collaborations. These efforts leverage Sweden's triple-helix model,

fostering close ties between government, industry, and academia to accelerate decarbonization.

Sweden's Trade Commissioner to India, Sofia Högman, highlighted the role of joint efforts in addressing global challenges. "This collaboration combines Sweden's sustainability expertise with India's ambitious environmental goals, setting benchmarks in green innovation," she said.

In line with the Swedish government's Asia initiative, Business Sweden has decided to establish a presence in Mumbai, its third office in India after Delhi and Bangalore. The aim is to be closer to Mumbai's financial center and the industrial region of Pune, which has traditionally been Sweden's business hub in the country.

"India is predicted to become the world's third-largest economy by 2030, driven by strong growth. The country is home to nearly 300 Swedish companies, while over 70 Indian companies have invested in Sweden, creating 7,000 direct jobs. Strengthening our presence and team in India will further enhance our ability to capitalize on this potential," says Jan Larsson, CEO of Business Sweden.

#### Strengthening Indo-Swedish Ties in Tamil Nadu

This continued cooperation reinforces Tamil Nadu's position as a hub for global business and sustainable innovation, fostering a stronger Indo-Swedish partnership.

#### Sweden's New Visa Rules to Open Job Options

Sweden will from January 1 introduce the European Union's updated Blue Card Directive, seeking to increase immigration of highly skilled professionals to the country. As Canada and the United Kingdom tighten immigration, Sweden is positioning itself as a prime destination for skilled workers, particularly in technology, engineering and health care.

"Indian nationals are the largest group of those moving to Sweden for work. Swedish employers value the skills that many Indians bring, particularly in fields like IT and engineering," said Jan Thesleff, Sweden's Ambassador of to India

The goal is to make it easier for skilled professionals to access high-paying jobs and establish long-term careers. The new directive includes reduced salary thresholds and more flexible opportunities for Blue Card holders to switch jobs without needing to reapply for a new card. This will benefit Indian professionals, as it simplifies the process of obtaining a Blue Card to work in Sweden.

### India-Norway Startup Collaboration: Strengthening Innovation Ties through Strategic Delegation Visit

A high-profile Indian delegation, including heads of three CSIR (Council of Scientific and Industrial Research) incubators, visited Norway from November 26-27, 2024, to explore and strengthen collaboration between Indian startups and Norwegian industries. The delegation engaged with key Norwegian companies and research institutions,

with discussions focusing on energy innovation, startup incubation, and sustainable technology.

At DNV GL, the delegation met with Lars Almklov (Director of Group Government and Public Affairs), Kåre Helle (Venture Director, DNV Ventures), and Amit Mital (Country Chair, India) to discuss how industries can collaborate with startups to drive innovation, particularly in the areas of risk management and sustainability. The delegation also visited SINTEF, a leading Norwegian research institute, where they met with Duncan Akporiaye and Thomas Moe Børseth to discuss the role of research institutions in fostering the local startup ecosystem.

At Equinor, the Norwegian energy giant, the delegation held discussions with Morten Halleraker (SVP, New Business & Investments), Uma Ranganathan (Director, Strategies), Rohit Singh (New Business & Innovation, Oslo), and Desikan Sundarajan (Country Manager in India, via video) on opportunities for collaboration in energy innovation, including joint ventures in renewable energy and sustainable infrastructure.

They also visited Gründergarasjen, an incubator, where they met Freyja Jørgensen (Head of Incubator and Acting CEO) to understand the incubator model in universities that do not have their own Technology Transfer Offices (TTO).

On November 27, the delegation also met with officials at the Ministry of Foreign Affairs, including Mr. Sigbjor Tenfjor (Director), Trym Oust Sonstad (Deputy Director), and Ms. Ann Ollestad (Senior Adviser for South Asia and Afghanistan), to discuss broader strategic and economic cooperation between the two countries.

This visit highlights the growing India-Norway collaboration in innovation, with both nations seeking to leverage their strengths in technology, sustainability, and research to foster a vibrant startup ecosystem.

Pawel Stachowiak, Counsellor for Trade & Economic Affairs at the EU Delegation to India, highlighted the growing significance of this relationship at the SIAL India 2024, an international food trade event held in Mumbai. The three-day event brought together key stakeholders from around the world to explore innovations and discuss challenges in the global food sector. The EU Pavilion stood out, showcasing European culinary excellence and highlighting opportunities for future collaboration in food security, sustainability, and innovation.

Stachowiak emphasized the immense contribution of EU-India trade in creating jobs, noting that over 2 million direct jobs and more than 4 million indirect jobs have been generated as a result of this collaboration. This job creation underscores the deepening economic ties and the positive impact on both regional and global economies. Stachowiak participated actively, exploring how the EU can continue to drive progress in food industry innovations and sustainable solutions. The event is a testament to the growing relationship between the EU and India, especially in sectors where both regions can leverage their strengths for mutual growth.

As both regions continue to build on this progress, the focus remains on driving innovation and deepening collaboration. The EU has shown a strong commitment to enhancing food security, addressing

#### India-Sweden Bilateral: 2024 in Review

The India-Sweden bilateral moved at a steady rate in 2024, with Sweden's foreign minister visiting India early on in the year and cooperation in priority sectors of innovation, sustainability, trade, and investment continuing via foreign office consultations. The two sides are committed to take forward their promises to explore cooperation in semiconductors, green steel, and green batteries.

The year was also eventful as Sweden officially became the 32nd member of the North Atlantic Treaty Organization (NATO). Apart from other responsibilities, this signaled the broadening of Sweden's role on the global stage. Indian Prime Minister Narendra Modi and his party the Bharatiya Janata Party won a landslide third consecutive term in the general elections. Through the official account of the Prime Minister of Sweden on X, PM Ulf Kristersson congratulated Prime Minister Narendra Modi on the victory of the BJP and its allies in the general elections held in India. Besides the congratulatory message, the strong ties between the two countries were emphasized, as well as the desire to continue collaborations, especially in accelerating the industry's transition to net zero via the LeadIT initiative. The seventh India-Sweden Foreign Office

Consultations included a range of regional and global issues of mutual interest, including cooperation in reforming the United Nations Security Council and enhancing India-EU bilateral relations, which have the potential to boost bilateral cooperation. June was also an important month for elections in Europe when the make-up of the new European Parliament was confirmed, highlighting the direction the European Union (EU) and its institutions will take in the coming years.

The focus on sustainability-centered ties was a highlight during the year, with sustainability, green transition, and innovation emerging as the three main pillars of India-Sweden economic ties. There was significant momentum in the India-Sweden Industry Transition Partnership (ITP). The ITP's mission is to accelerate the global decarbonization of heavy industry. It aims to do this by unlocking flagship projects in the steel and cement sectors and helping foster enabling conditions decarbonization by supporting innovation and research and development, mobilizing finance and advancing market-based mechanisms. Sustainability Day highlighted the two bilateral partners' intent to accelerate green transition efforts. The two sides have already committed toward adopting green practices in the areas of energy, environment, and urban development via several memoranda of understanding (MOUs). In line with the Swedish government's Asia initiative, Business Sweden has decided to establish a presence in Mumbai, its third office in India after Delhi and Bangalore.

India and Sweden have a long history of collaborations in various industries including in the space sector and 2024 saw a welcome boost as the Sweden-India Business Council and the Geospatial World Chamber of Commerce held the hybrid first meeting of the Joint Working Group (JWG) of the India-Sweden Space & Geospatial Business Industry. Just weeks before the JWG meeting, the Swedish Space Corporation (SSC) and the Indian Spacetech startup Dhruva Space announced to extend their ongoing collaboration to improve Indian-Swedish new space initiatives and further synergies on the satellite ground station networks. The year also saw

the Swedish government adopting Sweden's first defense and security space strategy. There is also potential for increasing naval activities (e.g., perhaps capacity building or naval interoperability) for a strengthened maritime cooperation, as the August visit of INS Tabar highlights. In March, Swedish company Saab started the construction of its new Carl-Gustaf manufacturing facility in Haryana state after receiving approval for 100 percent foreign direct investment. This is Saab's first facility outside Sweden for Carl-Gustaf and will be the first foreign fully owned defense production facility in India – a milestone for both India and Sweden.

As both nations continue to align their interests in 2025, their partnership could play a pivotal role in addressing global challenges and creating sustainable economic growth model.

#### Preparations for Putin's Visit to India in 2025

Preparations are underway for Russian President Vladimir Putin's visit to India, as confirmed by Kremlin aide Yury Ushakov on December 2. While no exact dates have been set, the visit is expected to take place in early 2025 at the invitation of Indian Prime Minister Narendra Modi. This marks Putin's first trip to India since the onset of the Ukraine war in February 2022.

Putin's visit will align with the protocol for reciprocal annual summits between Indian and Russian leaders. During his trip, he is expected to meet Modi for the 23rd India-Russia Annual Summit, following their last meeting in July 2024 in Moscow. Discussions will likely cover the recently established "economic



roadmap" for 2030, aiming to double bilateral trade to \$100 billion and bolster initiatives like the Chennai-Vladivostok maritime corridor. Trade between the two countries reached \$60 billion last year.

Defence Minister Rajnath Singh's upcoming visit to Russia underscores the deepening defense cooperation between the two nations. Singh will witness the commissioning of Tushil, the first of two stealth frigates under construction for the Indian Navy, with the second frigate, Tamal, expected in 2025. Other pending agreements, including the delivery of S-400 air defense systems, are likely to be addressed during these engagements.

Modi's potential role as a mediator in the Ukraine war will also be on the agenda. In 2024, Modi made significant diplomatic strides by visiting both Moscow and Kyiv, urging Russian and Ukrainian leaders to engage in peace talks. External Affairs Minister S. Jaishankar has reiterated India's willingness to facilitate dialogue between the conflicting parties. Kremlin spokesperson Dmitry Peskov emphasized the "special relationship" between Putin and Modi, highlighting their regular communication and mutual trust.

Putin's visit comes as Donald Trump is set to assume office as U.S. President in January 2025. Trump has expressed confidence in negotiating an end to the Russia-Ukraine conflict and has commended Modi's peace initiatives. The timing of these developments underscores India's pivotal role in global geopolitics, balancing its relationships with major powers.

Recent high-level meetings, including Russian Deputy Prime Minister Denis Manturov's visit to India, have laid the groundwork for Putin's trip. Manturov attended the Russia-India Business Forum in Mumbai, emphasizing cooperation in trade, science, and culture. As dates for the visit are finalized early next year, all eyes will be on the evolving dynamics of India-Russia relations amidst a shifting global landscape.

### Sweden Reinforces Civil Preparedness with Updated Crisis Handbook

Sweden has begun distributing an expanded version of its crisis preparedness guide, "In Case of Crisis or War," to millions of households. The guide, first introduced during World War II and revised periodically, reflects the country's response to an increasingly volatile security environment, particularly following Russia's invasion of Ukraine and Sweden's recent accession to NATO.

The new edition has doubled in size compared to its 2018 version and provides practical advice for coping with emergencies, including military conflict, prolonged power outages, and extreme weather events. It emphasizes the importance of individual and community resilience, urging citizens to maintain at least 72 hours' worth of food, water, and essential supplies such as medicines. Recommended items include non-perishable foods, potatoes, tinned goods, and prepared soups, alongside iodine tablets for nuclear incidents.

Civil Defense Minister Carl-Oskar Bohlin, who unveiled the booklet, noted that the global security situation has changed dramatically, necessitating more comprehensive guidance for citizens. The Swedish government's initiative aligns with similar campaigns in other Nordic countries like Finland and Norway. This latest effort reflects Sweden's evolving approach to national security, highlighting the importance of informed citizens in strengthening the country's resilience against contemporary threats.

### India's Bold Stand at COP29: Call for Justice in Climate Finance

The 29th UN Climate Change Conference (COP29) in Baku concluded with the adoption of a new climate finance goal, pledging \$300 billion annually by 2035 to aid developing nations. However, India's vehement objection to this deal underscored the Global South's dissatisfaction with what many see as insufficient commitments from wealthy nations.

India criticized the deal as an "optical illusion," arguing it falls far short of the \$1.3 trillion demanded by developing countries to meet escalating climate challenges. Chandni Raina, representing India, condemned the rushed approval process and the lack of ambition from developed countries. "This amount will not enable conducive climate action," she declared, reflecting broader frustrations among climate-vulnerable nations like Nigeria and Bolivia, which echoed India's sentiments.

Rich nations had initially proposed \$250 billion annually, raising the figure to \$300 billion amidst protests. Yet, the final deal lacks clarity on critical issues, such as the proportion of grants versus loans and specific allocations for least-developed countries and small island states.

India's leadership at COP29 highlighted the need for a fairer climate finance system. It opposed attempts to blur the lines of responsibility, ensuring the burden remains on historically high-emitting developed nations rather than shifting to emerging economies.

The summit's outcomes, including the "Baku to Belem Roadmap" for aligning global finance with climate goals, signal progress but fall short of addressing the inequities in the current system. India's stance has positioned it as a champion for the Global South, emphasizing the urgency of rethinking global climate negotiations to ensure inclusive and equitable action.

As COP29 wraps up, the debate over climate finance

underscores the persistent divide between rich and poor nations. With climate impacts worsening, India's call for justice serves as a rallying cry for developing nations to demand more from global leaders.
